Presentation by: Ryck Suydam – President of the NJ Farm Bureau

Ryck has operated Suydam Farms, LLC since 1985. The 300+ acre farm in Franklin Township, Somerset County, produces hay, straw, pumpkins, cut flowers, herbs, pigs, eggs and Christmas trees. Ryck is also a partner in Suydam Insurance Agency since 1987. Ryck was elected 2nd Vice President of New Jersey Farm Bureau in 2004. In 2012, Ryck was elected President of the New Jersey Farm Bureau. Some of Ryck's other community activities include serving as a director of the Belle Mead Farmers Co-op; a member of the Franklin Township Environmental Committee (1999-2002); Executive Vice President of the Franklin Township Chamber of Commerce; and Chairman of the Franklin Township Agricultural Advisory Committee. Ryck holds a Bachelor of Science Degree from the University of Maine. Ryck's family came from Holland in 1713 and bears a rich 300 year family farming history in this area. He will be speaking about the NJ Farm Bureau's support of the NJ beekeepers opposition to the proposed NJDOA Beekeeping Regulations and the political issues behind this fight. Ryck's presentation will also detail the mission of the NJ Farm Bureau as "A grassroots, membership supported non-government organization which is the largest advocate for agriculture in New Jersey, that represents all types of agriculture: equine, nursery, fruit and vegetable, field crops, apiary, wine grower, Christmas tree, forestry, livestock, etc."

Ryck encouraged the membership to contact and work together with the Farm Bureau At this time there are no beekeepers on the Board of Agriculture. The State Board of Agriculture is supported by the public.

Janet Katz, President of the New Jersey Beekeepers Association updated the membership regarding the newly proposed beekeeper regulations:

- 1100 negative comments were made about the newly proposed regulations, representing 36 municipalities. Only 18 comments supported the regulations.
- A committee is currently working on the regulations and categorizing the negative comments. However
 there are no beekeepers on this committee to help categorize the comments. Some of the comments are
 very technical and may be misinterpreted by someone who does not have beekeeping knowledge.
- Attorney Judith Gleason did not communicate with the NJBA regarding the new regulations. There were two meetings scheduled in two years. She has recently retired and has been replaced by another attorney who seems to be more receptive.
