 - a. Treasurer Report + Introduction of Audit Committee (Lew Goldberg + Brian Haluska): No audit report due. Treasurer Lew Goldberg thanked Curtis Crowell and Pat Evans (Past Treasurers) for their help and support during the Treasurer position transition. Treasurer's Report total: \$22,639.76. Lew indicated that the Market Rate Account will be rolled into the General Account in the near future.

 - c. Fair Chair + Upcoming Events + Oak Tree Lodge (Geff Vitale):

 The Monmouth County Fair will be held July 22nd 31st. Hours have increased and the fair will be open during the week until 11:00 PM. Saturday hours are 11:00 AM-11:00 PM and Sunday 11:00 AM-6:00 PM. - 7. New Business
 - a. Katie Culbert Publication in Journal of Research High School (JRHS) for Breakthroughs in Honey Bee Health: Continuous-Release Mist Diffusion of Thymol-Based Essential Oils:

Katie's latest research, Continuous-Release Mist Diffusion of Thymol-Based Essential Oils, Part II: The Field Study, has done very well in science competitions so far. In February, she was awarded first place among Poster Presentations at the Rutgers Junior Science and Humanities Symposium and is now a finalist competing at the National Junior Science and Humanities Symposium taking place April 20-23rd in Albuquerque, New Mexico. Most recently, she came in First Place in Animal Sciences at the Jersey Shore Science Fair at Stockton University and has advanced to the Delaware Valley Regional

Science Fair taking place April 6th in Philadelphia, Pennsylvania. Participants receiving medals at Delaware Valley will advance to the Regeneron International Science and Engineering Fair. As a follow-up to her laboratory research last year, (entitled "Breakthroughs in Honey Bee Health: Continuous-Release Mist Diffusion of Thymol-Based Essential Oils"), her research paper has been accepted for publication in the *Journal of Research High School* and will be published later this spring. Katie's winning 4-H essay, "Varroa, American Foulbrood, and the Amazing Honey Bee" was published in *American Beekeeping Federation Quarterly* (Vol. 79, No 4, 2021). This past Sunday, March 21st, Katie had her first 4H Busy Bees Beekeeping Club meeting of 2022. Her club received a grant from 4H to plant a pollinator garden at Jakes Branch County Park for her hives. In addition to these accomplishments, Katie has participated in her first YMCA Nationals. She swims for Greater Monmouth YMCA and will be competing in the 200 backstroke. She leaves for the YMCA Nationals in Greensboro, NC tomorrow and will return on April 2nd.

- b. Interest in Statewide NJBA In-Person Meeting: The membership was asked about future NJBA picnic plans. In the past, this picnic was held at Bob Hughes house and an auction also took place. The membership prefers to continue plans for the auction since members were able to bid on equipment. The picnic is also a networking opportunity. It was also determined that an hour drive for the location was acceptable.
- c. Cottage Foods: Bill Manley from the Department of Health has said that Raw Honey should be exempt from the list of non-TCS foods (foods requiring Time/Temperature Control for Safety) and has indicated that Raw Honey will NOT be treated as a Cottage Food product. Beekeepers who are selling Raw Honey do NOT require a Cottage Food License.

However, it is important to make the distinction between Raw Honey and Infused/Processed Honey, as the DoH will be regulating infused/processed honey.

During a recent meeting with Bill Manley from the NJ Dept. of Health, and at The New Jersey Environmental Health Association in Atlantic City on Monday, March 7, 2022, Manley said that Raw Honey is a perfect food and that inspectors should treat Raw Honey as they've always treated it. Inspectors should walk away from Raw Honey, as it does not require a Cottage Food License. He also said that he has no intention of issuing permits for Raw Honey.

This is incredibly good news, and strongly indicates that the Dept. of Health intends to exempt Raw Honey from the Cottage Food Regulations. It is also important to note that we still need to "see it in writing" for it be completely binding. Along these lines, Manley also reported:

The DoH is in the process of changing Chapter 24 of the New Jersey Administrative Code (N.J.A.C. 8:24), Cottage Food Operator Rule. They will be making amendments/changes throughout Chapter 24, including changes to Cottage Foods. Specifically, they will incorporate definitions of Raw Honey and Infused/Processed Honey.

The easiest way to make the distinction between the two is that Raw Honey is 100% Honey, while infused/processed honey is a product that contains honey *AND* additional ingredient(s). For a more detailed definition, please refer to the Good Management Practices For Harvesting Honey

Based on what Manley is saying, it is okay for beekeepers to sell Raw Honey, as he is saying that it does not require a Cottage Food License.

The NJBA Cottage Food Regulation's Committee is pleased that the DoH intends to amend the Cottage Foods Regulations by adjusting their definitions, thereby making Raw Honey exempt. However, while we are optimistic about this most

recent update, we will continue to push until this issue is fully resolved and put into writing.

Although Manley has indicated that the Department of Health will not treat Raw Honey as a Cottage Food Product, he also stated that they will otherwise be actively enforcing the Cottage Food Regulations. We encourage beekeepers who wish to continue selling processed honey products, such as infused/flavored honey, honey candy, nuts or fruit in honey, or honey that has *any* additional ingredient(s) added, to visit the DoH website to familiarize themselves with the requirements for a Cottage Food Operator

Last, Manley said he would intervene on behalf of any beekeeper selling Raw Honey that is questioned by a local health inspector and he will let the inspector know the DoH's interpretation of the regs. (Raw Honey vs.

8. Educational Presentation: Dr. Applegate ~ Honey Bee Veterinary Consortium (HBVC)

We were privileged to hear a presentation regarding honey bee health by Dr. Jeff Applegate. Dr. Applegate began by describing a VFD which is a written (nonverbal) statement issued by a licensed veterinarian in the course of the veterinarian's professional practice that authorizes the use of a VFD drug or combination VFD drug in or on an animal feed. This written statement authorizes the client (the owner of the animal or animals or other caretaker) to obtain and use animal feed bearing or containing a VFD drug or combination VFD drug to treat the client's animals only in accordance with the conditions for use approved, conditionally approved, or indexed by the FDA. Dr. Applegate organized the Honey Bee Veterinary Consortium in 2017 which is designed to involve beekeepers and the state apiarist. The mission of the Consortium is to promote honey bee health, encourage collaboration between veterinarians, apiarists and

entomologists and to distribute honey bee related educational material and scientific information. The Consortium has grown to 22 states, 4 countries and is currently international. Dr. Applegate is presently involved in developing a honey bee Veterinary Certification Program which will focus on AFB and EFB diagnosis, treatment and proper handling. In addition, procedures for vets to visit bee yards has also been outlined and addressed. Dr. Applegate continues to research and develop these topics. His presentation was informational and inspirational to all!
